Data Protection Declaration In connection with the AIFF Centralized Registration System

- 1. The objective of the AIFF Centralized Registration System (CRS) is on the one hand to make sure that footballs' authorities have more details available to them on each and every transfer, and on the other hand, to increase the transparency of individual transactions, which will in turn improve the credibility and standing of the entire transfer system. At the same time, the system will also ensure that it is indeed a player who is being transferred, that the movement of the player or is being used to move money ("money-laundering"), in addition the system will safeguard the protection of minors.
- 2. Personal data will be transferred and processed over the CRS. This information will include but is not limited to Club Data, player and minor's data, contractual and compensation amount data.
- 3. AIFF Centralized Registration System (CRS) warrants that the data will be collected, processed and transferred in accordance with the requirements of the Indian Law on Data Protection.
- 4. CRS will verify that the technical and the organizational measures undertaken by ______ ("Club/Association") as user of the CRS are sufficient to protect the received data from any unauthorized processing as required.
- 5. The Club acknowledges that transactions executed by CRS contain highly confidential data. The disclosure or improper use of such confidential information may cause substantial damage to parties which are involved in a transfer of a football player.
- 6. The Club will keep all the data obtained on the access to CRS strictly confidential and take all reasonable measures and apply the highest degree of care in order to guarantee at any time complete confidentiality. Furthermore, the Club will use the confidential information exclusively for the purpose of accomplishing player transaction in which he is directly involved.
- 7. The Club will keep the group of persons who have access to the CRS ("Authorized Persons") as small as possible. The Club furthermore commits to select, instruct and control the Authorized Persons to sign the attached declaration of the confidentiality and due care. The Club will provide AIFF CRS department without delay about any change with regard to the list of Authorized Persons.
- 8. The Club will promptly inform and cooperate with AIFF CRS department if any accidental or authorized access has occurred.
- 9. AIFF CRS department as well as the Club are responsible that persons affected (data subject) are provided with the right of information, correction, blocking, suppression or deletion, as available under the Indian Law. They will fully cooperate to perform requests or inquiries of persons affected.

- 10. The Club will inform the persons affected (data subject) about the processing of their personal data, about the possibilities of how to make use of the right of information, correction, blocking, suppression or deletion and about the data receiver in cases where personal data are disclosed to a third party.
- 11. The Club unconditionally agrees to fully, indemnify, defend and hold AIFF CRS department as well as AIFF or any of its subsidiaries, representatives or employees harmless from and against any and all claims, expenses (including legal expenses), damages, settlements or other liabilities, resulting from or arising out of any non-compliance with the obligations of the Club under these declarations.
- 12. The Club furthermore unconditionally waives any liability of the AIFF CRS department, AIFF or any of its subsidiaries, representatives or employees, etc. for any damage that the Club may suffer due to any abuse of information by third parties. The waiver of the liability does not apply in the case if deliberate or grossly negligent behavior.
- 13. These declarations are subject of substantive Indian Law. The place of jurisdiction is Delhi, India.
